

## Regulatory Jurisdiction Areas by License Type

To determine the licensing and inspection regulatory authority for facilities in North Dakota, first determine the license type column and find the corresponding location of operation under the areas covered. If the corresponding space does not have an "X" or the location is not listed in the "Areas Covered" column, then this license is under the regulatory jurisdiction of the ND Department of Health Division of Food and Lodging.
