


North Dakota Immunization Information System: Provider Inventory Report

The Provider Inventory Report provides a printable PDF document of all doses on hand for your provider site. Report options include the ability to include doses of expired vaccine if desired, as well as to provide separate private and state supplied vaccine dose counts.

How To Run a Provider Inventory Report:

1.) The Provider Inventory Report is located under the Provider Inventory Reports report type in the NDIIS reports module

5.) After all fields have been selected, click **Run Now** or **Run Later** to run the report.

6.) Return to the Saved Reports tab to check the status of your report. You may need to hit the **Refresh** button to update the Reports listed. When the status column lists your report as Completed, click the **View** button to open your report PDF.
